### **PRIORITIES FOR RENTAL APPLICATIONS**

- NOW – March 15, 2010:**      **2009 City of Neenah Resident Renters**, for the stall they occupied last season, or for a stall previously occupied by a non-resident.
- March 17 – March 31, 2010:**      **Any City of Neenah Resident**, for any vacant stalls.
- AFTER April 1, 2010:**      All other applicants, **by lottery**.

### **POLICIES**

1. Stalls may be occupied starting May 1, 2010 and must be vacated no later than November 1, 2010.
2. FULL PAYMENT is due at the time of application
3. All information MUST be complete on the application form, including your **Wisconsin Boat Registry Number**.
4. Refunds on seasonal rentals may be made at the discretion of the Parks & Recreation Department. If the space can be re-rented on a pro-rated basis, you may receive your funds back less a 10% administration cost.
5. The boat stall renter must be the owner of the occupying boat. Renters of stalls will not be permitted to sub-lease their stalls.
6. The sale of your boat does not transfer occupancy of the stall to a new owner. People on a waiting list will be given the opportunity to occupy the space.
7. No storage of boats or gear can be provided at Shattuck Park between November 1 and the opening of the next boating season. Boats and gear left in the storage area after November 1 will be subject to additional storage rates.
8. Any keys issued to renters for access to the facility must be returned to the Parks & Recreation Office when vacating your stall for the season. Report the loss or theft of your key(s) immediately.
9. The Parks and Recreation Department assume no responsibility for the loss of equipment, or damage to the boat while occupying this facility.
10. If a renter is not making regular use of a stall, the Parks and Recreation Department reserves the right to revoke the lease and issue a pro-rated refund.
11. Occupants may not fill gas tanks, transfer flammables, create safety hazards, or transfer hazardous materials to the river while occupying a stall.
