Re: Fireworks Stand Regulations

The following requirements of Neenah-Menasha Fire Rescue, the authority having jurisdiction, shall be met to have a Fireworks Stand in the City of Neenah and the City of Menasha:

1. The sale of fireworks, at a fireworks stand, to an individual that does not have a permit is limited to those items listed in Wisconsin State Statute 167.10(1)(a)-(n). Such items that can be sold to individuals without a permit are not allowed to explode and/or leave the ground.
2. The sales of any fireworks that require a permit as described in Wisconsin State Statute 167.10(1)-(9) are prohibited at a fireworks stand.
3. A fire extinguisher with a minimum rating of 2A:10BC shall be located at the fireworks stand. The fire extinguisher shall have a current inspection/service tag.
4. Open flames, including any type of smoking, shall not be permitted within 25 feet of the fireworks stand.
5. The area around the fireworks stand shall be kept clear of brush, dried vegetation, leaves and similar combustibles for at least 25'.
6. No smoking signs shall be posted.
7. Tent(s) must be flame retardant material and a certificate of affirmation shall be available.
8. A permit for a fireworks stand must be applied for and issued through the City Clerk's Office in the City of Neenah. Vendors must notify Neenah-Menasha Fire Rescue before fireworks are sold in the City of Menasha. Neenah-Menasha Fire Rescue will do an inspection and approval of the fireworks stand.
9. All fireworks stands and sales must comply fully with the State of Wisconsin Comm. Code, Chapter 167, safeguards of person, section 127.10 regulation of fireworks.

In the event that the Fire Chief or his designee feels that a violation has occurred or an unsafe condition is present the vendor will cease all sales and/or be issued a citation for violations.
