AN ORDINANCE

The Common Council of the City of Neenah, Wisconsin, do ordain as follows:

Section 1. That the Official Street Map, as established by Section 26-30 of the Neenah Municipal Code, is hereby amended as follows:

By amending street reservations located in part of the Northwest 1/4 and the Northeast 1/4 of the Southeast 1/4 of Section 19, Township 20 North, Range 17 East, Town of Neenah, Winnebago County, Wisconsin as follows:

By removing a street reservation, 66 feet in width, the centerline of which is defined as follows: Commencing at the East 1/4 corner of said Section 19; thence North 89 degrees 38 minutes 49 seconds West, along the North line of said Southeast 1/4, a distance of 1779.27 feet; thence South 00 degrees 21 minutes 11 seconds West, 287.82 feet to the point of beginning of said centerline of officially mapped right-of-way to be removed; thence South 71 degrees 20 minutes 52 seconds East, 1185.71 feet; thence South 89 degrees 38 minutes 59 seconds East, 660.03 feet to the East line of the Southeast 1/4 of said section 19 and the end of said centerline; and

By adding a street reservation, 66 feet in width, the centerline of which is defined as follows: Commencing at the East 1/4 corner of said section 19; thence North 89 degrees 38 minutes 49 seconds West, along the North line of said Southeast 1/4, a distance of 1779.27 feet; thence South 00 degrees 21 minutes 11 seconds West, 287.82 feet to the point of beginning of said centerline of proposed officially mapped right-of-way; thence 263.18 feet along an arc of a curve to the left, having a radius of 800.00 feet and a chord that bears South 80 degrees 47 minutes 05.0 seconds East, 261.99 feet; thence North 89 degrees 47 minutes 27 seconds East, 505.66 feet; thence 318.76 feet along an arc of a curve to the right, having a radius of 250.00 and a chord that bears South 53 degrees 40 minutes 55.0 seconds East, 297.60 feet; thence South 17 degrees 09 minutes 17 seconds East, 106.02 feet; thence 381.01 feet along an arc of a curve to the left, having a radius of 450.00 feet and a chord that bears South 41 degrees 24 minutes 39.0 seconds East, 369.73 feet; thence South 65 degrees 40 minutes 01 seconds East, 150.26 feet; thence 168.02 feet along an arc of a curve to the left, having a radius of 400.00 feet and a chord that bears South 77 degrees 42 minutes 03.0 seconds East, 166.79 feet; thence South 89 degrees 44 minutes 05 seconds East, 128.74 feet to a point on the West right-of-way line of C.T.H. "CB" and the end of said centerline. **Section 2.** Repeal and Effective Date. All ordinances or parts of ordinances and resolutions in conflict herewith are hereby repealed. This ordinance shall take effect from and after its passage and publication.
