Recycle String Lights



The City of Neenah will once again be participating in the Holiday String Lights Recycling Program sponsored by Winnebago County Solid Waste. There is a collection bin at City Hall, 211 Walnut Street, for residents to bring holiday lights to recycle. The program runs from November 18, 2024, to January 31, 2025.

Lithium Batteries

Lithium batteries, also known as rechargeable batteries, require special disposal and should not be thrown into household trash or recycling. These batteries have the potential to overheat, catch fire, and explode, releasing toxic and flammable gases. 

Garbage and Recycling Collection Routes



CARTS

- Carts are the property of the City of Neenah. They are assigned to the property.
- Place carts at the curb no later than 6:30 AM on the day of your collection and remove them within 24 hours of collection.
- Place carts at the curb with the front of the lid facing the street.
- Do not place yard waste, large items/metal, hazardous materials or leaves in your garbage or recycling cart.
- Please allow a minimum of 3 feet between each cart and other objects (utility poles, trees, mailboxes, etc.).
- Residents can request an additional 95-gallon garbage/recycle cart for an annual fee.
- Residents can request a change in cart size for a \$25 per cart exchange fee (No charge for new owners).




BULKY ITEM & METAL COLLECTION

The City of Neenah offers bulky item & metal pickup curbside during the even months of the year. (February, April, June, August, October, and December). Bulky items are charged \$15 per item and include furniture (sofas, chairs, tables, etc.), mattresses, carpet (cut to 3 feet wide and rolled), doors, windows, and a limit of 2 bundles of lumber (maximum size 4 feet long and 2 feet in diameter). Extra bags of refuse and smaller items that would normally fit in your city-issued refuse cart will not be picked up during this time. Residents can purchase the bulky item stickers in the Public Works Office located at 211 Walnut Street, 3rd Floor, or online at neenahwi.gov/departments/public-works/recycling-and-refuse/large-item metal-pick-up. If purchased online, the stickers will be mailed out the following business day.

If your bulky item(s) or metal are on the curb earlier than 24 hours before your scheduled collection, they may be removed by the City, and the property owner may be charged a minimum of \$105 special collection fee.

2025 Drop-Off Center Punch Card

Watch the mail in February 2025 for the Drop-Off Center Punch Card. The punch card will be your identification to use the drop-off center. Cards will be mailed to occupants of residential property with 4 living units or less. Must have card for entrance. Below is an example of what the card will look like.

This card is your access to use the City of Neenah Drop-Off Center. Residents will need to bring this card every time regardless of the Item(s) they bring. Residents may occasionally be asked to provide an additional form of identification (e.g., driver's license, etc.) to spot check for non-resident use.

Not all items brought to the Drop-off Center will require a card punch (see table below). Each card provides 3 (three) punches to drop off bulkier items. Once the 3 punches have been used, new cards may be purchased with a limit of 2 per calendar year. The cost for the first card is \$30 and the cost for the second card is \$45. Cards can be purchased at City Hall in the Public Works Department or online at www.neenwi.gov.

Attendants have the right to refuse large amounts of debris and may direct citizens to the Winnebago County Solid Waste Facility. Consider donating items to reuse centers, but always call ahead to ensure the item can be donated.

Recycling Don'ts

- Putting garbage, liquids and food in the recycling make it difficult and costly to sort clean recyclables. If you are unsure of what to do with an item, use the Waste Wizard (above) or contact the Public Works office.
- Tanks and compressed gas cylinders can contain small amounts of fuel and can ignite if damaged.
- Tanglers are any materials that wrap around sorting equipment, such as cords, hoses, wires, and light strings, clothing, bedding and towels. Including these types of items in recycling can create unnecessary maintenance.
- Batteries should never be placed in the recycle cart.

Facility Rules

- Visitors are required to stop at the scale office before entering the site.
- All vehicles and trailers must be tarped from your point of origin, not just prior to entering the landfill. Non-tarped loads will be denied access to the unloading areas
- No Smoking while outside of your vehicles.
- No alcoholic beverages
- · Children and pets must stay in vehicle
- Scavenging is not permitted
- Facility employees are not permitted to help unload
- If damage to your vehicle happens, please report it to the scale office immediately



Alkaline batteries (regular household batteries) are not considered hazardous. Alkaline batteries may be placed in your household trash for disposal.

Household hazardous waste material is disposed of at the Winnebago County Household Hazardous Waste Facility. Service is available to Winnebago County residents with household sourced materials from personal use. This is a seasonal collection facility accepting material **by appointment only** from April through October. Appointment dates will open 4-weeks in advance.

Check the labels! Many of the household materials accepted are labeled as corrosive, poison, flammable or combustible.

Hazardous waste from distributors, business use, farm use, out-of-county sources, radioactive materials, infectious/medical wastes, asbestos, and medications <u>are not accepted</u> at the Winnebago County Landfill or Household Hazardous Material Collection Facility. Call for more information.

YARD WASTE & BRUSH

The City of Neenah is implementing a new yard waste and brush collection schedule in 2025. The changes are being made to address work tasks that have suffered from lack of time for a concerted focus on such areas as asphalt street patching, mastic road repairs, inspecting/repairing catch basins, cleaning catch basins, tree trimming, retention pond maintenance, roundabout landscaping, sealing concrete, jetting storm sewer, and weeding concrete islands. The new schedule will still be based on the area of the city that residents live in, but will take place on Mondays of the even months of the year, April, June, August, and October.

Collection Guidelines

- All yard waste and brush must be placed curbside by 6:30 AM on the collection date.
- All yard waste must be in 35-gallon garbage cans with handles, bushel baskets, or smaller containers that weigh less than 50 pounds. You may use 30-gallon biodegradable paper bags. Do not use plastic bags or cardboard boxes for yard waste.
- Small amounts of brush should be bundled, 2 feet in diameter by 4 feet long, and tied with heavy cord (not wire) or placed in 30-gallon biodegradable paper bags or placed loosely in cans.
- Large branches, up to 3 inches in diameter, should be kept long and placed adjacent to the street with the cut ends facing the same direction as traffic flow would be for your side of the street.
- The city does not pick up from vacant lots or contractor-generated brush.
- If yard waste or brush is on the curb earlier than 24 hours before your scheduled collection, it may be removed by the city and the property owner may be charged, at a minimum, a \$105 special collection fee.

TERRACE TREES



Trees that are planted between the street and sidewalk (also known as the terrace) are the property of the city. The City of Neenah plants and maintains all trees in the terrace area, which includes trimming the tree and checking for disease. Residents can call the Public Works office if a tree on the terrace is in need of trimming.

CHRISTMAS TREES

Crews will collect trees in January once they see trees start to accumulate on the curbs. The collected trees will then be shredded and/or donated to local ice fishing clubs to mark the ice on Lake Winnebago for sturgeon spearing.



Schedule change for 2025 leaf collection

The Department of Public Works is continually looking for ways to improve and simplify processes for residents. Leaf collection is one of those processes which can be difficult to schedule because it is weather-driven. Staff reviewed the current collection process and have made the following change to leaf collection starting in the fall of 2025. If residents have questions, they can contact the Department of Public Works.

The Department of Public Works will collect leaves starting Monday, October 13th, and end on Friday, November 22nd. Crews will follow a regular rotation of the city, starting on the northeast part of the city. It will not be possible to accurately tell residents the exact day their leaves will be picked up. Residents can look to social media for updates or visit the leaf collection website by scanning the QR code to view the interactive collection map.

Collection Guidelines

All leaves must be loose on the terrace. No plastic bags or containers of leaves will be collected. To avoid polluting storm sewers and to prevent traffic hazards, do not rake leaves into the street. Collection is subject to weather conditions and will continue until either weather prohibits (snow or ice) or the last scheduled collection day is reached, whichever comes first.




Grass Clippings

Grass clippings are not accepted at the drop-off site, nor should they be placed in yard waste bags or residents garbage or recycling carts. Residents are encouraged to compost grass clippings. If that is not an option, residents can take grass clippings to the Winnebago County Solid Waste Facility in Oshkosh. (Fees may apply)


Street Sweeping

The Street Department is in charge of sweeping the 130.56 miles of streets in the City of Neenah. Street Sweeping starts typically in April and continues until the weather gets cold.

Catch Basins

A catch basin is receptacle beneath the ground that collects and redirects unwanted surface water from sidewalks, driveways and streets. It allows water to flow through inlets or grates into an underground system of pipes, then channels it away from holes or low-lying areas that are prone to flooding. Catch basins are also vital in containing pollution and debris that would otherwise enter natural waterways that could harm aquatic life and create health hazards for nearby communities.



WINTER/SNOW

Winter Snow Guidelines

- Please keep sidewalks shoveled and salted. City
 ordinance states that owners or occupants of any
 lot or parcel in the City are required to remove all
 snow and ice from sidewalks within 24 hours after
 the cessation of the snow event.
- Please do not park in driving lanes where snow has accumulated in the parking lane.
- Please do not park vehicles in the street after a snow event. Please see winter parking rules on page 12.
- Please stay back a minimum of 5 car lengths from snowplows and do not pass snowplows on the right side.

- It is against city ordinance to blow, plow, push or deposit snow into the any public roadway from commercial or residential properties. Violators may be ticketed.
- Adopt a catch basin to help prevent flooding by keeping snow and ice cleared.
- Do not place garbage/recycle carts on top of snow banks or in the road.
- If parking on streets during the day, please allow enough room between cars parked on both sides of the street, for plows to get through.

General Parking Rules

The city limits overnight parking in order to efficiently provide services that keep public streets and parking lots clean of debris and clear of snow. For this reason, parking overnight from Midnight to 5 am is restricted depending on the type of street and the time of the year.

Overnight Parking on Residential Streets

- Park on the even house-numbered side of the street on even number days
- Park on the odd house-numbered side of the street on odd-numbered days.
- For determining which day is odd or even, use the calendar date the night of the date you want to park on the street. For example, if you park your car at 10PM on the 14th, your vehicle should be parked on the even side of the street, If you park your car at 2AM on the 15th, your vehicle should also be parked on the even side of the street.
- If there is no parking on one side of the street, the alternate side parking method does not apply to that section of the street. Residents are then allowed to park overnight on the available side of the street but not for more than 24 hours.
- If you live on a cul-de-sac, the alternate side parking method does not apply to that section of the street. Residents are then allowed to park overnight on the available side of the street but not for more than 24 hours.

Temporary Parking Exemption

If you will be having company, or need to place a dumpster in your driveway or have other reasons that you may need to park temporarily in the street, please contact the Neenah Police Department by calling the non-emergency phone number at 920-886-6000.

Dumpsters on City Streets

If you're looking to place any of the following items within the public right-of-way (city sidewalk, street, or terrace), you will need to apply for a Street Occupancy Permit.

- Portable storage containers
- PODs
- Dumpsters
- Gravel/soil piles
- · Commercial/construction equipment

Please note that any obstruction will need to be barricaded with reflective sheeting if placed overnight. The City does not provide barricading materials; it is expected that the dumpster provider will provide or contract out any materials required. For more information, see City Code <u>26-550(1)(f)</u>.



Trailer Parking on City Streets

Parking trailers on city streets and parking lots is not permitted unless it is hooked on a vehicle. All parking regulations still apply.




OTHER IMPORTANT INFORMATION

Mailbox Placement

The United States Post Office sets the guidelines for the placement of mailboxes.

Where to Place the Mailbox

- Position your mailbox 41" to 45" from the road surface to the bottom of the mailbox or point of mail entry.
- Place your mailbox 6" to 8" back from the curb. If you do not have a raised curb, contact your local postmaster for guidance.
- Put your house or apartment number on the mailbox.
- If your mailbox is on a different street from your house or apartment, put your full street address on the box.




Installing the Mailbox Post

- A 4" x 4" wooden support or a 2"-diameter standard steel or aluminum pipe.
- Avoid unyielding and potentially dangerous supports, like heavy metal pipes, concrete posts, and farm equipment (e.g., milk cans filled with concrete).
- Bury your post no more than 24" deep.

Shredded Paper

Small amounts of shredded paper may be brought to the drop-off site in grocery size brown paper bags. The bags must be stapled shut.

Styrofoam Disposal Available for Neenah Residents



Outagamie County recently announced the "Foam Dome," a new drop-off recycling program for Styrofoam or foam polystyrene. Acceptable foam can be taken to the drop-off at the Outagamie Resource Recovery Park, located at 1919 Holland Rd Appleton, for no charge. The Foam Dome accepts: CLEAN Expandable Polystyrene (EPS) (hard, white packaging foam used to protect televisions and appliances); CLEAN food packaging foam (foam egg cartons, foam takeout containers, and foam cups); Unacceptable material includes foam board insulation, packaging peanuts, flexible foam, foam cushions, painted foam, dirty or wet foam.
