## Yard Sale Sign Requirements

If you plan to have a yard, garage, rummage, estate or other similar sale, you must meet the following sign requirements:

- □ Yard sale signs can be located within the public right-of-way, behind the curb. The signs shall be located within four blocks or 1,000 feet of the property conducting the sale, whichever is less, and permission shall be obtained from the abutting property owner.
- Yard sale signs shall not exceed a height of three feet or a total area of six square feet in area and shall display the address at which the sale is being conducted and the dates of the sale.
- □ Yard sale signs may be installed 24 hours prior to the first day of the sale and must be removed within 24 hours of the end of the sale.
- Yard sale signs shall be self-supportive and shall not be placed on or affixed to any telephone pole, electric pole, street light pole, traffic signal, traffic sign, public tree or any other similar structure or appurtenances within the right-of-way.
- Yard sales can be conducted three times per calendar year, with no sale to exceed three consecutive days.
