### POLICIES & INFORMATION

- Stalls may be occupied starting May 1, 2023, and must be vacated no later than November 1, 2023.
- FULL PAYMENT is due at the time of application
- All information MUST be complete on the application form, including your Wisconsin Boat Registry Number.
- Refunds on seasonal rentals may be made at the discretion of the Parks & Recreation Department. If the space can be re-rented on a pro-rated basis, you may receive your funds back less a 10% administration cost.
- The boat stall renter must be the owner of the occupying boat. Renters of stalls will not be permitted to sub-lease their stalls.
- The sale of your boat does not transfer occupancy of the stall to a new owner. People on a waiting list will be given the opportunity to occupy the space.
- No storage of boats or gear can be provided at Shattuck Park between November 1 and the opening of the next boating season. Boats and gear left in the storage area after November 1 will be subject to additional storage rates.
- Any keys issued to renters for access to the facility must be returned to the Parks & Recreation Office when vacating your stall for the season. Report the loss or theft of your key(s) immediately.
- The Parks and Recreation Department assumes no responsibility for the loss of equipment, or damage to the boat while occupying this facility.
- Occupants may not fill gas tanks, transfer flammables, create safety hazards, or transfer hazardous materials to the river while occupying a stall.
- The city periodically cuts aquatic weeds. Renters may need to clear floating weeds from their stalls.
- Electric outlets available on light posts for intermittent use.
