

The 2022-2026 City of Neenah Comprehensive Outdoor Recreation Plan seeks to help preserve the natural environment and at the same time allow residents and visitors alike to play, learn, enjoy and live in harmony with it. In addition to setting forth new recommendations based on present needs, the adopted plan will enable the municipality to compete for matching funds available through the Department of Natural Resources' Stewardship Program if available. Funding components of this program, targets monies for parkland acquisition and development projects as well as for numerous other projects and activities that preserve, protect and enhance important land and water-based natural assets. Collectively, other grants are available through the WDNR Stewardship Program, Wisconsin Department of Transportation, etc. and have effectively doubled the local funding commitment for acquisition and development of parkland and improvements to other public recreational facilities such as trails. A 50% match is required.

## **Chapter 1: Introduction**

#### **EXECUTIVE SUMMARY**

Broadly defined, parks and recreation are facilities and programs provided for the purposes of leisure, entertainment, and spare time pursuits. These facilities, include but are not limited to parks, playgrounds, athletic fields, pools, nature areas and trails. The City of Neenah Parks and Recreation Department offers many options to recreate and enjoy the outdoors. This Comprehensive Outdoor Recreation Plan or CORP, will address an inventory of provided facilities and also look at what is needed in the future.

Although recreational preferences may vary from individual to individual, parks offer a significate place in offering quality of life importance. With the lessons learned from the recent COVID-19 pandemic in 2020-21, outdoor spaces served as free spaces to get fresh air and in doing so, increased the usage of parks. Maintenance of parks and enough staff to accomplish the growing demand is an important issue to look at when offering quality active and passive recreational pursuits.

#### **PLANNING PROCESS**

Appropriate standards are utilized in conjunction with a detailed inventory of existing parks and recreational facilities. Population and physical area statistics are incorporated to provide the base for recreation space analysis and projections. Individual sites are reviewed as to utilization and potential. The need for specific facilities is based upon current use and capacities, and considered judgments of the demands of the future and is highlighted in Chapter 4, Needs Assessment.

#### **PURPOSE**

The primary purpose of the Comprehensive Outdoor Recreation Plan is to provide a guide for acquisition and development of Parks and Recreation facilities, in order to meet the outdoor recreational needs of the current and projected population of the City.

Government at all levels recognizes its responsibility to assist in making recreation opportunities available to every citizen, necessitating a plan. The City of Neenah continues to develop and periodically revise plans to provide these services for its citizens.

This report includes a review and compilation of previous plans. It provides for the development of newly acquired sites, and presents the most recent data and recommendations pertinent to Parks and Recreation planning.

With the acceptance of this report by City Officials and the State Department of Natural Resources, the City of Neenah meets its planning requirements to continue eligibility in the following programs: Federal Land and Water Conservation Fund (LWCF), Aids for the Acquisition and Development of Local Parks (ADLP), Urban Green Space (UGS) and Urban Rivers Grant Program (URGP).

The Comprehensive Outdoor Recreation Plan and the five-year Capital Improvement Program detailed in this report are meant to serve as a guide. Yearly projects will be determined through the annual budget process.

# 10 GUIDING PRINCIPLES OF THE PLANNING PROCESS

- 1. Realize that the growth of the City in population and area increases the need for open space and outdoor recreation sites.
- 2. Recognize that more people participate in a broader variety of recreation, particularly outdoor activities. People have a greater concern with their environment and the conservation preservation of natural, historical and cultural resources.
- 3. Solicit and encourage wide citizen participation in the plans for the development of parks and recreation facilities.
- 4. Coordinate the City of Neenah Comprehensive Outdoor Recreation Plan with the City of Neenah 2040 Comprehensive Plan, Neenah Trails Task Force Plan, 1997, the Regional Comprehensive 2030 Plan of the East Central Wisconsin Regional Planning Commission, the plans of other City of Neenah functions, and the plans of neighboring governmental units.
- 5. Provide sites and facilities that meet or exceed appropriate recommended standards.
- 6. Recognize that the plan for a specific site should consider the unique features of the site, community interests and preferences, as well as general development standards.
- 7. Promote the development of appropriate multi-use facilities.

- 8. Consider the problems of "over-use" and "mis-use" of facilities, especially those facilities with special natural features.
- 9. Provide an action plan which is reasonable and reflects the community's priorities and resources.
- 10. Provide for periodic review and evaluation of the plan to keep it current and appropriate.

#### TIMELINE OF THE PLAN

#### April - May 2021

Initial fieldwork and inventory of existing sites was completed by City Staff and members of the Parks and Recreation Commission.

#### March 14, 2021

The planning process began with a kickoff meeting of the Parks and Recreation Commission and ECWRPC.

#### May 2021 - September 2021

A public survey was initiated via the SurveyMonkey website.

#### July 2021

A level of service analysis was performed to look at access and walkability from each park. A mile-based buffer, per park type, was used surrounding each park the City maintains. A half mile is typical walking distance. Barriers may be present such as busy streets, railroad tracks, etc. that may make distances greater even the location is close.

#### September 2021

Survey results were analyzed and a needs assessment was performed from the public comment. First draft of plan was given to the Parks and Recreation Director for review.

#### September - October, 2021

Parks and Recreation Staff presents Recommendations (Chapter 6) to Parks and Recreation Commission for modifications and approval.

#### October – November 2021

Preliminary recommendations were presented to the Parks and Recreation Commission, along with the 5-year Action Plan. The Plan was posted on the City website.

#### December 2021

Recommendation for Adoption was made by the Parks and Recreation Commission.

#### December 2021- January 2022

Adoption (Chapter 8) for the CORP was approved by the Parks and Recreation Commission, Public Services and Safety Committee, and the City Council.

#### PHYSICAL SETTING

The City of Neenah is 9.6 square miles and was incorporated on March 13, 1873. Neenah was named by Governor James Duane Doty for the Winnebago word for "water" or "running water". It was the site of a Ho-Chunk village in the late 18th-century. The area was first designated as an industrial and agricultural mission to the Menominee Indians in 1835, and early settlement by Americans of European descent began a few years later. Proximity to the Fox River played a major role in lumber and paper production. The major paper mill Kimberly-Clark was established here in 1873.

The city of Neenah is the southwestern-most of the Fox Cities of northeast Wisconsin. It is the smaller of the two principal cities of the Oshkosh-Neenah, Wisconsin Metropolitan Statistical Area, which is included in the Appleton-Oshkosh-Neenah Combined Statistical Area. Its population was 25,501 at the 2010 census. Neenah is sometimes referred to as a twin city of the City of Menasha, with which it shares Doty Island.

The terrain in and around Neenah is flat to gently rolling. Elevations within the city range from 754 feet above sea level. Major developed land uses are commercial, residential and industrial.

Besides Kimberly-Clark, Neenah hosts significant paper related industries. Some of these include Neenah Paper, Bemis Company and Menasha Corp. Neenah is the headquarters of Plexus, a developer and manufacturer of electronic products, which also has engineering and manufacturing operations in the city. Manhole covers manufactured at Neenah Foundry can be found throughout the central United States and parts of Europe. Also headquartered in Neenah is Theda Clark Hospital, and Alta Resources, specializing in outsourced customer care.

Residential areas are scattered throughout the city, but most recent residential growth has occurred on its perimeter, particularly on the south side of the City near the industrial park and north of CTH G in Liberty Heights and Pendleton Road.

#### NATURAL AND ENVIRONMENTAL RESOURCES

The Neenah Creek runs through the City from the south end of Little Lake Butte des Morts to

CTH G. The waterway flows between Arrowhead and Herb and Dolly Smith Parks, west of Washington and Baldwin Parks where fishing exists, through the Bridgewood Golf Course and down to just east of the Carpenter Preserve. Through this area wetlands, 100-year floodplain and soils with a depth to bedrock less than 60 inches exists. Woodlot areas are also scattered throughout the undeveloped areas.

Neenah means water and is surrounded by a bountiful area of resources. Lake Winnebago is located to the east, the Fox River flows through the northern quarter and Little Lake Butte des Morts southern tip reaches the North boundary of Arrowhead and Herb and Dolly Smith Parks. The south half of Doty Island is also located in the City making it a unique area with the channels of the Fox River dividing the land and forming the Island. The Oak St. and Commercial St. Bridges act as overpasses to connect the Cities of both Menasha and Neenah.

## **Chapter 2: Goals and Objectives**

#### **GOALS AND OBJECTIVES**

Goals are defined as general statements of desirable ends, where objectives measure statements of those goals to obtain them. They are common ideals of the community that can be achieved through the actions of government leaders, private organizations, and individual citizens. Together, the goals and objectives provide a basis for establishing City policy regarding the planning, acquisition and future development of park and recreation facilities. Goals and Objectives follow the 2040 Comprehensive Plan guidelines.

The following goals are developed from seven Goal categories:

- 1. Health & Fitness
- 2. Variety of Activities
- 3. Conservation
- 4. Accessibility & Design
- 5. Partnerships
- 6. Cost Effectiveness
- 7. Quality of Life

Upon adoption of this plan, the following goals and objectives were developed and reviewed by the City of Neenah Parks and Recreation Commission and City staff at the October 21, 2021 Park and Recreation Commission regular meeting. A Goal\* visioning session was initiated to develop new ideas and items that can better the overall parks system. They are intended to serve as a guide for creating the type of park and recreation system the City's residents would enjoy.

#### Goal 1

Maintain, enhance, and establish a community-wide system of parks, open space, and park facilities that will provide all residents of Neenah with adequate recreational opportunities.

(Health, Variety, Accessibility, Quality of Life)

#### **Objectives:**

1. Provide active and passive recreational areas and facilities that can be utilized by all without regards to age or ability. Address maintenance, upgrades, ADA requirements, and current needs identified for park and recreational facilities.

#### Goal 2

Facilitate and support the development of a comprehensive system of bicycle and pedestrian trails and routes through the City. (Health, Variety, Accessibility, Partners, Cost, Quality of Life)

#### Objectives:

- 1. Identify gaps within the trails system where accessibility can be improved.
- 2. Undertake city-wide improvements to signage, wayfinding, and connections to destinations.

#### Goal 3

Preserve the natural resources and areas located within the city such as wetlands, woodlands, and areas threatened by urban development. (Health, Variety, Accessibility, Quality of Life)

#### Objectives:

- 1. The City should take measures to ensure the preservation of natural areas. Where it is feasible, natural areas should be targeted for acquisition and inclusion as part of the park and open space system, particularly when these areas are threatened by urban development.
- 2. Utilize water resources in the downtown area to increase recreational opportunities.
- Maintain and expand public access and accessibility to the Neenah Creek and areas along the Lake Winnebago and Fox River shorelines.

#### Goal 4

Offer recreational programming and acquire services that meet the needs of all Neenah residents. (Variety, Health, Partners, Cost, Quality of Life)

#### **Objectives:**

1. Promote the City's parks and recreational system, and support new activities and facilities that will meet the diverse needs and interests of all age groups.

#### Goal 5

Facilitate and support the development of <u>new</u> parks and facilities as growth occurs based on needs analysis. (Health, Variety, Accessibility, Partners, Cost, Quality of Life)

#### **Objectives:**

- 1. Select and reserve future park locations now so new neighborhoods will develop around them.
- 2. Provide park facilities for existing neighborhoods that are under-served, particularly in the northwest and south-central areas of the City. Identify future accessible park land for growth areas.
- 3. Consider acquiring land/vacant building for a community center (long-term).
- 4. Implement the recommendations in the Arrowhead Park Master Plan. Encourage "Park Ambassadors" to guide the development.

#### Goal 6

Encourage cooperation with adjacent municipalities, the Neenah School District, Local Groups and organizations to maximize the costeffectiveness of providing open space and recreational facilities. (Partners, Cost, Variety)

#### **Objectives:**

- 1. Continue to partner with the Neenah public and private schools and community organizations for the use of facilities, including recreational facilities and to explore new collaborative efforts and see equitable ways of sharing the burden for acquiring, developing and maintaining parks and other recreational facilities.
- 2. Work jointly with local sport / service clubs to improve and expand indoor / outdoor recreational facilities.
- 3. Solicit the support of community groups and service organizations as a way of funding and/or undertaking improvements benefiting residents of the City.

In formulating goals and strategies, the Park and Recreation Commission provided their input for the next five years, using the seven topic, 1- 10 score system, (with 10 being the highest). In Table 2-1, an overall average of 8.3 for all topics was determined. Conservation ranked the lowest at 6.6 with the rationale of more can be done with the Carpenter Preserve and outlying areas. Variety of Activities scored the highest at 9.2. Table 2-2 gives the overall results and average scores per topic. These are the scores given by the Park and Recreation Commission, not the public.

The City of Neenah Park and Recreation Commission's overall assessment score was 8.3 out of 10. The highest standard deviation occurred on the Conservation and Partnership topics. When comparing the City to other communities who have completed this same assessment, the City of Menasha scored a 7.8, City of Waupaca scored an 8.8 and the City of New London a 7.9. Fox Crossing average of 8.3 tied with Neenah and falls slightly above the range of Menasha and Waupaca.

A S.W.O.T .(Strengths, Weaknesses, Opportunities, and Threats) analysis was also performed by the Park and Recreation Commission to gain insight on additional improvements and recommendations that can be added in as strategies for the next five years. Here are the detailed results showing the pros and cons:

- Need longer bike trails, a larger skate park needed, no community building.
- We need more funding to develop and maintain our parks.
- We could do more to increase accessibility to some neighborhood parks. (e.g. Douglas)
- Some past deficiencies are being addressed. In the past with no dog park which is presently being addressed.
- We could have more aesthetically welcoming floral and landscaped entrances.
- Review when restrooms can be open for the public, May 10<sup>th</sup> or 15<sup>th</sup> still seems late. The threat of deep frost us really gone by then.
- Look at programming that would be attractive to high school kids.
- People want trash removal.
- People want Fresh Air Park improved.
- The balance of court usage might be a challenge in some parks.

#### **Opportunities**

What recreational opportunities does Neenah promote? What recreational trends could you take advantage of? How can you turn your rec strengths into opportunities?

- Partnering with the YMCA, Brigade, Youth Go. We should have a park and rec app. The
  website is good and the flyer is good but we could reach even more people. It could
  have reminders/notifications. Calendar features that inform you of events and activities.
  Sign-up times can be as a touch of the app. Could we combine with Menasha to offer
  more things? Could we work with the school district to combine efforts?
- Programs for all ages, staff already does a great job.
- Great Leadership can only do so much with time and budget issues holding back creating new programs or expansion of current ones.
- Pickleball has arrived and introductory classes would be welcomed.
- Promotion of programming thru our activity booklet is a good way to promote Neenah Park and Rec with new recreational interests.
- Having a savvy staff that sees and knows what is happening in other geographical areas is key in presenting new programs so they don't get stale.
- We promote our access to water, and the trees and greenspaces we have.
- Trends? Cross country skiing/ maintained trails/ making snow? To draw people to our area?

#### **Threats**

What threats are harming Neenah's recreational areas?
What is your competition doing better? i.e. Menasha, Fox Crossing, Appleton, Oshkosh How are the City's weaknesses being a threat to the parks and rec department?

- That depends on what we want to be. Club sports continue to creep into the younger ages. That might take away a certain segment but that also leaves more opportunity, I have not been on the commission long enough to look at the surrounding issues that may be a threat.
- Keeping up with the pickleball demand, maintaining trails, available budget to maintain the current parks and programs along with finishing projects that are planned.
- The biggest threat to our parks system is lack of money. Every year the park
  commission and staff are required to care for more and more assets with an
  unreasonable limit of resources to care for them. I don't think this helps when we are
  required to use bond aide to fix major problems.
- Competition from outside interests for summer and fulltime staff. We must keep ahead of the trends. Better pay and benefits to keep valuable staff.
- We need to keep vigilant on the use of our parks for unsanctioned activities. e.g. protests are potentially threatening to other park users.
- City must be aware of societal demands for workforce and potential shortages. The City must be aware that with new housing, new parkland may be required. Perhaps a shift from small parks to larger park areas.
- If parks are added, additional staff will be required.

## **Chapter 3: Recreational Resources**

#### INVENTORY AND EVALUATION

The City of Neenah recognizes its responsibility to provide adequate, safe, attractive and varied facilities through the Parks and Recreation Department with a focus on families. It is also important, however, to recognize the existence of other facilities in the <u>public and private sector</u> that help meet the needs of the citizens of Neenah.

This section contains an inventory and evaluation of existing parks and facilities and notes facilities that should be considered for the future. Facilities assessed include resources in the City of Neenah and school district that are accessible to the public for use. Accessibility to various facilities differs, based on location, jurisdictional standards and fees. This is taken into consideration in the evaluation of the following specific facilities.

All facilities listed are **public and outdoor** unless otherwise noted.

- Indicates parks and facilities maintained by the City of Neenah
- ♦ Indicates facilities maintained by the Neenah Joint School District

#### INVENTORY OF EXISTING PARKS AND FACILITIES

#### **Archery Range**

Located adjacent to the city's municipal garage, the range offers at-grade or raised shooting options.

#### Arrowhead Park (26.65 acres)

The current park land was originally lake bed filled in beginning in 1952. The paper sludge land fill was closed in 1975 at which time the land was dedicated as a park. Four Conceptual Master Plans have been developed for the park in 1952, 1973, 2008 and again in 2017. Current development includes a portion of the Loop the Lake Trail and a parking lot that is shared with a local business. Continued development per the 2017 Conceptual Master Plan is ongoing.

#### Baldwin Park (2.9 acres)

A neighborhood park located along the Neenah Creek provides water access for fishing and quiet water launching. The park consists of open space, a full-size basketball court and play equipment. Play equipment is scheduled for replacement.

#### Bill Miller Park (6.22 acres)

Located in the Mahler Park subdivision, the neighborhood park consists of an open-air shelter, play equipment, backstop and open space.

#### **Carpenter Preserve Park (102.13)**

Largely made up of natural areas of upper woodlands and marsh. Currently the park has a tot lot play area and a wood-chipped nature path following the stream. A master plan has been developed for the park (2008). The city should develop the park in accordance to that master plan and consider acquisition of the land north of the play area should the school district divest its interest in the property.

#### Castle Oak Park (3.0 acres)

A fairly new neighborhood park, this is located in the south side of the city and consists of open space and play equipment.

#### Cook Park (2.4 acres w/new area)

Cook Park is located along the Loop the Lake Trail on Doty Island. Recently, the city acquired 2 3 residential lots enlarging the access and visibility of the park from the street that was listed in the CORP Plan. A fourth lot as indicated in the CORP should be acquired. Facilities include a play area, a shelter with restrooms with an overhang and a sledding hill. The park is scheduled for redevelopment within the next couple of years.

#### **Community Gardens (3 acres)**

Along with the land donation for the dog park. There are approximately 3 acres of current community gardens. The current non-profit organization will continue to operate and be responsible for the gardens.

#### Dog Park (4.25 acres)

Newly acquired land will be developed in to a dog park facility over the next couple of years. It will be located on the corner of Byrd and Brooks Ave next to the Police Station and Community Gardens.

#### Doty Park (9.25 acres)

Doty Park is located along the north side of the Neenah Channel of the Fox River. It is home to the historic Governor James Doty cabin. The park consists of 2 dedicated tennis courts and pickleball courts with 4 pickleball court and a half-court basketball court overlays, a unique shelter, play equipment, 2 architecturally unique stone bridges that cross the channel leading to a rentable gazebo and 2 boat launches with 21 trailer parking stalls. The park has historically been used as backdrop for weddings, senior or homecoming pictures. The park seawall is scheduled for redevelopment.

#### Douglas Park (4.3 Acres)

A relatively obscure neighborhood park, this park has limited access via two points off of Douglas Street. The park consists of an open space, a shelter and play equipment. Continue to evaluate access points.

#### Fresh Air Park (1.68 acres)

Fresh Air Park is the only park not located within the city of Neenah boundaries. It is located adjacent to Lake Winnebago in the Town of Neenah with a parking facility, a beach and winter access to the lake. The plan for improvement includes replacement of the park drive and includes the possibility of a vault single toilet and changing facility.

#### **Great Northern Park (10.5 acres)**

Great Northern is located in the southeast section of the city with a large open space that is used by the local soccer club. The park also consists of a play area and shelter. No current improvements are planned.

#### Green Park (1.60 acres)

"The Green" is the oldest park in the city. An ice rink with a warming shelter, two tennis courts with two pickle ball court overlays, and a play area are located in the park. The shelter is available for rent from April through October.

#### Herb & Dolly Smith Park (2.5 acres)

This park is located on the southwest shores of Little Lake Butte des Morts with a portion of the Loop the Little Lake trail running through it. The park supports shore fishing, quiet water launching activities and provides access to Arrowhead Park and the downtown. There is an open shelter for rent and a parking lot.

#### Island Park (2.5 acres)

Located at the base of the Neenah Dam, Island Park has a parking lot and small restroom. The park is used heavily in spring for fishing. The park was identified in a 2001 Waterfront Design and Development Master Plan for improvement.

#### Kimberly Point (3.5 acres)

"The Point" provides amazing views of Lake Winnebago with over 830 feet of shoreline. The park is used throughout the day by park guests for early morning coffee breaks, snack lunches and reflection. Fishermen can be found along the shoreline from predawn until well after sunset. The historic Kimberly Point Lighthouse with restrooms is located on the property. Improvements include extending the Lakeshore Drive bike and pedestrian pathway through the park, and shoreline & pier improvement.

#### Laudan Park (2.0 acres)

This park is used as a site for summer recreation programs with play equipment and an open field that has been used for soccer and flag football. The play equipment is scheduled to be updated within the next couple of years.

#### Liberty Park (2.65 acres)

Liberty is a relatively new park located in the southwest corner of the city. Currently, the park consists of play equipment, a half-court basketball area and open space.

#### Memorial Park (105 acres)

The city's largest park consists of many active and passive recreational opportunities. Active recreation includes five designated soccer fields, three designated ballfields, a volleyball court, two separate play areas, an ice rink and a sledding hill. Passive recreation includes asphalt and wood-chipped trails, open space and a hardwood urban forest. The Tullar play area is scheduled to be replaced to meet current safety and ADA requirements. There are four different rental facilities located within Memorial Park.

#### **Quarry Park (5 acres)**

A neighborhood park, Quarry Park consists of open space, a sledding hill and play equipment.

#### Recreation Park (8.33 acres)

"Rec" Park is located on the west shore of Lake Winnebago and provides access to the Lake Winnebago for boaters with 5 launches and 53 boat/trailer parking stalls, including a power wash station. The Neenah Pool is also located at Rec Park and can host 699 guests with a supporting parking lot.

#### Riverside Park (19.85 acres)

Lovingly referred to as "Rocket Park," this park's play area represents a space shuttle that replaced the historic rocket ship play area. Riverside consists of a mature urban forest, shoreline access to the Neenah Harbor and a connecting asphalt path. Also located in the park is the city's largest pavilion which is used for large community/regional events and a band shell that hosts the historic Riverside Players Theater and the Neenah Community Band.

#### **Shattuck Park (1.6 acres)**

Adjacent to the downtown, Shattuck Park provides access to the Neenah Harbor and boat rental slips, a quiet water launch with an architecturally unique shelter and open space. Summer concerts in the park and the Saturday Farmers Markets are sponsored by Future Neenah.

#### Skate Park (1.5 acres)

Recently updated in the 2017, the Skate Park is an all-concrete ramp system designed for beginners and intermediate boarders/bikers. There is space available for future expansion.

#### Southview Park (27.4 acres)

Southview is a community park that consists of 4 ballfields, a batting cage, 1 basketball court, 1 soccer field, 6 lighted tennis courts, and a mature hardwood urban forest with asphalt trails and supporting facilities. There is an outdoor shelter available for rent.

#### Washington Park (11.5 acres)

Washington Park recently underwent redevelopment that was completed in 2019. The redeveloped park includes 2 tennis courts, 2 dedicated and 4 overlay pickle ball courts, a discovery ballfield, a fully ADA accessible play area, splash pad, basketball court, a repositioned ice rink, asphalt trails and supporting facilities. A rentable indoor shelter is available.

#### Wilderness Park (19.45 acres)

Located on the east side of Neenah, this natural area consists of woodchipped nature trails.

#### Whiting Boat House (.5 acres)

An historic rental facility, this building is used mainly for weddings, graduation parties and holidays. The boat house stores the Coast Guard Auxiliary and WI-DNR boats during the boating season.

#### PRIVATE SERVICES

**Boys and Girls Brigade** offers programming for middle school to high school students. The indoor facility is near downtown and offers many specific programming rooms, a gym and auditorium. The Parks and Recreation Department rents the facility in Summer for the successful Operation Recreation program.

**Bridgewood Platform Tennis.** Year–round, heated court facilities use to play what is a combination of tennis, pickleball and racquet ball. More recently the facilities have been sponsoring pickleball court times.

**The Neenah/Menasha YMCA** offers recreational programs for infants to older adults at an indoor facility located near downtown Neenah. The Y has historically focused on physical fitness and sports. A summer Y day camp is currently held at Memorial Park. At times, the Park and Recreation Department has offered cooperative recreational programming.

#### **FACILITIES INVENTORY**

#### **ARCHERY RANGE - 1**

The permanent range at the City Services Building was rebuilt in 2014 and includes a raised shooting platform, 6 targets and has a handicapped accessible route.





Facilities are currently adequate.

# BASEBALL / SOFTBALL DIAMONDS - 13 Baseball/Softball popularity has increased in recent years. Baseball diamonds are used by youth leagues through Neenah Baseball, Inc. (NBI) and NPRD instructional programs. The Southview Park facilities have been developed with funding assistance from NBI and Scheel's.

Diamond use includes: NPRD, church leagues, a high school interscholastic league and neighborhood use. Since the last writing, there are no longer adult leagues. This is due to a historical / regional downward trend of participation in adult leagues and programs.

A new recreational refrigerated rink is scheduled to open in 2022 in downtown Neenah in Gateway Plaza. The NPR Department may need to reconsider the number of ice rinks needed in the future.



#### **PLAYGROUNDS - 24**

#### SPLASH PAD - 1

An interactive splash pad was installed in Washington Park. The splash pad is just under 2,885 sq. ft and is a flow system which does not require fencing and supervision. The City may want to consider another splash pad as this facility sees a lot of use during the summer months.



#### **SWIMMING POOLS - 2**



The Neenah Pool is an outdoor facility, designed primarily for recreation and instruction. It features a zero-depth area, a 131' flume slide, a deep well with drop slide and one-meter diving board, four lap lanes, concession stand, sand play area, volleyball court, tetherball and park ping pong table. The Department runs a comprehensive swim lesson program.

The high school pool is an indoor facility designed primarily for instruction, competition and exercise.

Road and trail running remains popular. Cross country meets are held at Riverside and Memorial Parks. NPRD sponsors a successful Summer Fun Run Series at Memorial Park. The Fox Cities Marathon and numerous 5k

walks and runs utilize Neenah Parks, trails, and streets.

#### TRAILS (off-street)

The *Neenah Access Trails System* is made up of on-street trails (Map 2) and paved off road trails. The paved trails are designed for use by bicycles, in-line skaters, runners and walkers. These trails are also listed on the *Trails of the Fox Cities* map.

The city completed the Neenah trestle connecting Arrowhead Park to Doty Island in 2018. This connection along with trail work completed in the city of Menasha and Village of Fox Crossing allowed for the development of the 3.5-mile Loop the Little Lake. This "Loop" permits trail users to pass through 3 communities and over four trestles.





### **Chapter 4: Recreational Needs**

#### **NEEDS ASSESSMENT**

Recreational needs, facilities and parks and open space within the city of Neenah are evaluated based upon many factors. These factors include but are not limited to: community demographics; national and local benchmarks; national and local trends; and input from citizens, elected officials and Park and Recreation Commissioners.

To assess recreational needs, the Parks and Recreation Commission and Staff conducted an analysis and inventory of current parks and recreational facilities. Analysis focused on recreation facilities that are: not currently provided; deficient; or in need of improvement. After review, recommendations will be development to help the city achieve the goal of providing residents with a wide variety of recreational opportunities. Recommendations are listed in Chapter 6.

Parks and Recreation needs may include the demand for additional park lands based upon new residential developments or in areas where "park deserts" exist within the community or the need for new or improved park facilities and equipment. Generally, local and nation recreation standards, benchmarks and trends are used to identify these demands as well and most importantly local citizen input.

#### **COMMUNITY DEMOGRAPHICS**

Neenah's 2020 population of 26,333 reflected a 4 percent increase over its 2010 population of 25,501 (Table 4-1). Based on DOA estimates, the City was home to 26,010 residents in 2015. Neenah's population has fluctuated within a fairly narrow range for several decades now and likely will continue to do so in the future. Projections indicate that its population will continue its steady growth from current levels, reaching 28,970 by 2040. During this timeframe, both the State of Wisconsin and Winnebago County are expected to experience modest population gains. (Table 4-2)





#### LAND NEEDS

There are two different methodologies used to determine land needs. The first is based upon total acreage without regard to access or ability to use the dedicated park lands while the second methodology is based upon useable acreage. Both models have pros and cons. There is value in reviewing and considering both models when making decision regarding current and future park land needs.



The first model looks at all dedicated park land and assumes that no new lands will be acquired for park lands through 2040. The City of Neenah has 14.85 acres of land per 1,000 residents totaling 391.1 acres. Local and national bench marks indicated a range of 10 – 14.5 acres per 1,000 residents. There are 27,319 residents within the City. The model suggest that Neenah could provide a range of 273.13 - 396.13 acres of dedicated parklands resulting in a surplus ranging from 117.37 to a deficit of -5.57 acres in 2020 and a range of 101.4-acre surplus in 2040 to a -28.97 deficit.

The land mass is showing additional acreage, but most of the land is unusable for recreational activities. Carpenter Preserve is mostly marshland, with woodlands located within Memorial and Wilderness Parks. Additional land mass is mostly for passive

Perhaps a more useful tool would be to look at the active park lands and that are available for use by the City of Neenah residents. The City of Neenah Park and Recreation Department / Commission manages open space that is largely inaccessible to the residents or is undeveloped. While these lands are valuable to the community due to the ability to reduce stormwater run-off, create green ways and preserve wetlands/ urban forests from any future development the average resident will not have either immediate or future active use of these lands. Deleting a portion of these lands from the calculation changes the current parklands and acres per 1000 calculation. Below is a chart calculating these inaccessible lands.

While not advocating for changing the current model being used it would be helpful to consider accessibility when considering future land acquisitions. Of the three park spaces listed below, only 25% is considered accessible.



Based upon the second model, the range of 10 - 14.5 acre /1,000 capita standard, Neenah's park land acreage need for today ranges from a 6.8 surplus to a deficit of 116.14 acres. Projecting into the future and assuming no additional park land is obtained, the deficiency in

2040 would grow from 9.71 to 140.08 acres. As noted, Arrowhead Park will soon become accessible to the Neenah residents and shift to the dedicated park land calculation.

Ultimately, decisions related to park land acreage should not only consider total dedicated acres, acres per 1,000, but public access, usability, and locations of park lands as well. Of greater importance and consideration is the location of park lands in relationship to neighborhoods and walking distances.

#### NATIONAL / LOCAL BENCHMARKS

The National Recreation and Parks Association (NRPA) has established industry benchmarks for dedicated park lands within communities. NRPA clearly states that these should be considered guideless with each community determining what is in their best interest.

East Central Wisconsin Regional Planning Commission (ECWRPC), as part of its *Long-Range Transportation/Land Use Plan for the Fox Cities, Oshkosh, and Fond du Lac Urban Areas* (October 2010), has identified a level of service standard for parks, which is 10 acres for every 1,000 residents. ECWRPC created residential standards based on density for various services such as sanitary sewer, water supply, street network, and parks. The high-density category is defined as 3 or more residential units per acre.

These industry wide standards are useful bench marks when reviewing and comparing a community's park land needs. The City of Neenah does not provide Mini Parks within its park system, while Neighborhood Parks fall just within the range and Community Parks fall below and with Open Space greatly exceeding benchmarks. The City of Neenah also provides for a Special Use classification which include the pool, boat launches, event spaces, and fishing areas.



#### **LOCATIONAL NEEDS**

It is desirable that recreational opportunities be within convenient walking distance of each of a community's residents, with its compact development pattern and distribution of existing parks and schools, virtually all Neenah residents live within a few minutes' walk of an existing recreation facility. When residents are separated from the nearest park or school by natural barriers such as streams or man-made barriers such as busy streets, they are considered to be less adequately served because these features hinder a direct or safe walk within ½ mile.

According to the results of the 2021 community survey, only 13% said they were unable to safely walk and/or bike to a park. The barriers stated were no sidewalks on Green Bay Road, State Highway 76, no sidewalk on County Highway G to connect Liberty Heights, traffic along Wisconsin Avenue. Busy streets with no sidewalks and safe crossing routes were the bulk of the comments.

This is a particular concern for children and disabled or elderly residents. Looking at the Neighborhood and Community Parks in Neenah, excluding natural areas,

the neighborhoods southwest of USH 41 / Breezewood Lane and south of CTH G fall within this category along with the northwest and northeast corners of the City boundary of being somewhat underserved. Capacity or growth, quality and condition, & location and access all affect service in these areas, (Map 4). School Parks offer some amenities but these are not always accessible during a specific timeframe.

#### LEVEL OF SERVICE AREAS (LOS)

Level of service of parks is determined through standards by park size and type. It is used as a guide with the present and future population to determine need. Parks provided by a community should serve 100% of its residents if possible with the combination of parks offered. The service areas for community parks and special facilities may serve citizens beyond the municipal boundary as residents use parks from neighboring communities.

To measure walkable parks from residential areas, a walkshed analysis was used as well as "Crow Flies" to show the routes a person would take versus just a buffered zone. A walkshed is

the network of streets within a defined walking distance of a specific location, such as a park. Walksheds are a more accurate way to identify actual walking routes and distances to destinations. Unlike approaches that measure straight-line distance to a destination, walksheds attempt to consider gaps in the network where streets don't connect or where there may be physical barriers, cul-de-sacs, etc. (Figure 4-4).

Mapping walksheds on the sidewalks and trails network helps identify individual segments that pedestrians are likely to take to a specific destination within a given distance or travel time. This shows existing connectivity between modes of transportation within a walkshed. On average, a person can walk up to half a mile in 10 minutes, which is a commonly

recommended distance for pedestrians to access available park land or open space in their community. Using the half-mile recommended service area and parcel data, all residential parcels and sidewalks are mapped to show which households are within the park service area for the City of Neenah.

Based on the walkshed assessment, when you analyze as the Crow Flies," with a half mile buffer from each park and or facility, the walkability from a residential structure is 86%. When looking at sidewalks and trails as your route to get to your destination, the walkability is less, at 67% since there are barriers present that have to be utilized instead of a direct straight line. This is more accurate as it shows the route directly on the ground. Walkability is limited in the southwest and western pockets of the city as barriers exist such as major highways. Neenah is split east and west due to Interstate 41 and the railroad tracks. Overpasses give access but are also dangerous in crossing due to traffic.

#### **FACILITY NEEDS**

The composition of a community's population can provide insight into the need for emphasizing specific types of recreational opportunities. Neenah's population distribution by age group compares closely with that of Winnebago County (Table 4-9). However, in 2010, Neenah had proportionally more residents aged 25-44(27.5%), than the county and state (22.9%, 25.4%). The City's population shows a "young, middle-aged" based community which the facilities should be structured around with family-oriented activities.



#### PARK CLASSIFICATIONS AND LEVEL OF SERVICE STANDARDS

While the National Recreation and Park Association's (NRPA) Park, Recreation, Open Space and Greenway Guidelines provides definitions for park classifications, it acknowledges that each community is unique in terms of geographical, cultural and socioeconomic make-up. As such each community or park agency should develop its own standards for recreation, parks and open space, with the NRPA definitions as a guide. Typically, municipalities focus on Mini Parks, Neighborhood Parks, Community Park and Open Spaces. Historically, the City of Neenah has provided Neighborhood, Community, Natural Resource Areas and Special Use Parks.

As a means of organizing the public park and open space facilities found in the City of Neenah, the park areas are classified according to a hierarchy that provides for a comprehensive system of interrelated parks. Some parks that meet neighborhood needs and have specialized amenities could be placed into more than one classification, but are placed in the classification that meets the broadest definition. The park and open space classifications that are appropriate for the City of Neenah do not necessarily meet the NRPA guidelines in a strict sense as far as size or amenities, but are appropriate to the overall offerings.

#### ACCESSIBILITY FOR PERSONS WITH DISABILITIES

A community's recreational programs and activities play an important part of the life of community. No physical or policy barriers should exist that keep people with disabilities from participating. The City of Neenah is committed to providing ample recreational options for persons with disabilities, but also recognize that some trails and non-play areas may not be conducive to such improvements due to topography and other site factors.

When new recreational facilities or alterations to existing facilities and amenities are made, they both must comply with the and comply with Americans with Disabilities Act (ADA) standards. It is the goal of the Parks and Recreation Department to implement appropriate guidelines and recommendations for existing and future recreation facilities. Currently, not all park facilities, walkways, trails, play equipment, and restrooms are fully accessible for persons with disabilities. However, the City has made progress in improving such facilities, and continues to incorporate ADA standards into new or improved park facilities.

#### <u>Survey Comment from Neenah</u> Resident:

"We live in the Nature Trail subdivision off of Pendleton Road. We do not have any parks on our side of Breezewood Ln. We REALLY need a park with playground equipment on this side of Breezewood Ln. Our neighborhood continues to grow and we need to provide a safe place for kids to play. Crossing Breezewood Ln on bikes is not safe for young children. Walking to our closest park, which is Memorial, is not feasible for young children. PLEASE reconsider this decision that was vetoed last vear!"

There are several outdoor recreation facilities that are currently under construction such as Arrowhead Park that will be accessible by all members in the community. These projects highlight the commitment of residents and the City to eliminate access or mobility barriers to outdoor recreation amenities.

The City will continue to incorporate ADA design standards into the development or expansion of parks which includes playground equipment or other amenities purchased and/or replaced as identified in the detailed master park plans. Parks were ADA has already been successfully implemented are Herb Dolly Park kayak launch, and in Washington Park playground, splashpad, and ball diamond.

Careful attention should be given to areas of the city where people with lesser means to ensure equal opportunity to be physical active. In many large cities, low income neighborhoods often lack quality recreational programs, playgrounds and parks. They can also be hindered in accessing nearby facilities by physical and land use barriers (i.e. transportation, water corridors

and industry). Barriers in Neenah include, USH 41 which splits the City in half north/south while STH 114 runs east/west creating "quadrant neighborhoods". Railroad tracks that run along Harrison Street also is considered a barrier. Flashing beacons to calm traffic are located on STH 114 to allow for pedestrian and bicyclists crossing. Overpasses can be a hindrance if beacons are located at the end of a hill.

Silent water sports such as kayaking, canoeing, and paddle boarding are also high on the list of what enthusiasts are doing with their free time. In the snow months snow shoeing, sledding, ice skating, and cross-country skiing round off the list of activities.








Figure 4-12: Top Park Needs by Category

The top needs for all park categories were to offer bottle filling stations at parks, more paved off -road trails, nature trails, and a disc golf course. Activities that City residents didn't feel they needed more of were archery, outdoor ping pong tables, a pump track, or designated photography spots. As trends and conditions change, along with population dynamics, flexibility to update parks and activities with the needs of the people is something the City of Neenah should strive for.

#### **Statewide Trends**

To effectively provide the right type of recreational activities and facilities, the City needs to better understand broader recreational trends. The graphic to the right reflects the statewide recreational trends from the 2019-2023 Wisconsin Statewide Comprehensive Outdoor Recreation Plan (SCORP) and also identifies most participated in as well as what is needed in their county.

### Description of Lake Winnebago Waters Region

The region is home to the popular sturgeon fishing season. Urban and suburban development within the region continue to grow in the Fox River Valley.


#### PARK IMPACT FEE LAW

Park and recreation needs <u>may include</u> the need for additional parkland to accommodate new facilities, the need for additional parks in areas not adequately served by existing facilities, or where new residential growth is occurring. This also may include the need for new or improved park facilities and equipment. Park Impact Fees are tool the City can utilize to assist in new park development before a subdivision is created.

Wisconsin Statute Section 66.0617 pertaining to park impact fees states:

"A needs assessment that justifies why a fee should be imposed is required under section 66.017(4) a. A municipality may not impose a park fee in its subdivision ordinance as a condition of subdivision plat approval. Municipalities have authority under section 66.0617 to impose a fee on new land development for capital costs to construct, expand, or improve park facilities. This includes the cost of land for, among other things, parks, playgrounds, and athletic fields needed as the result of new development." A municipality may enact an ordinance under this section that imposes impact fees on developers to pay for the capital costs that are necessary to accommodate land development.



# **Chapter 5: Health Needs Assessment**

### 2021 COUNTY HEALTH COMPONENTS AND STATISTICS

With obesity rates on the rise, Neenah's need to promote active recreation should be a priority. From the 2021 Winnebago County Health Rankings<sup>1\*</sup>, (with 1 being the best), Winnebago County is rated 41 overall out of 72 for health outcomes and 16 out of 72 for health factors. When compared to the other counties in the state, these County Health Rankings illustrate what we know when it comes to what's making people sick or healthy, but understanding the City of Neenah through Winnebago County's rankings is only one component of improving the community's health. The "Roadmaps to Health" Action Center provides tools to help groups work together to create healthier places to live, learn, work and play. For example, In Winnebago County, the group "re:Th!nk Winnebago" is one such group who has started this process in working with the East Central Wisconsin Regional Planning Commission (ECWRPC)on health in planning initiatives.

Improving community health requires people from multiple fields to work collaboratively on an ongoing cycle of activities. Communities may be at different points in this process. ECWRPC has developed a bicycle and pedestrian plan for the Fox Cities to help guide this process. A plan of this nature will help fill in those voided connections residents are asking for while still planning for future active communities.

To enable and encourage the citizens of Neenah to be physically active, a **strengthening of support and funding** for the City's Park and Recreation Department's facilities, and recreational programming should be considered. "Park Prescriptions" along with a Mayoral Challenge could be written to encourage active use and enjoyment of the City Park and Recreation System. **Improvements**, that positively impact public health and recreation such as connecting parks and places with trails as well as park facilities that encourage exercise. And, thirdly, **maintenance** of heavily used facilities such as Riverside, Memorial and Washington Parks that need constant care as well as **development** of under used parks Quarry, and Douglas. All new facilities need to be ADA accessible according to Title III.

Continued support with community partnerships such as sport clubs, organizations, non-profits, citizen groups, companies, and other interested parties to develop, fund and operate recreation programs, leagues, and events are keys to success. These partnerships are invaluable in helping to provide opportunities for people to be physically active.

Parks, playgrounds, and open spaces provide opportunities for physical activity. However, the presence of facilities is not enough to make sure they are being used for the greatest benefit of all. Factors such as location, accessibility, programming, connectivity, safety and aesthetics all play a role in the use of public facilities. By incorporating natural and design elements that have cultural or homeland meaning, will also help represent minority populations. Investing in consistent/uniform signage that aids people in identifying trails, places to be active, and other rec opportunities, should be considered. Promoting and marketing concepts should be developed along with the funding resources identified such as studies done through the Transform Wisconsin grant program.




Figure 5-1: Overall County Health Outcomes and Factors Ratings

Figure 5-1 demonstrates where <u>the County</u> stands in the state as compared to the other 72 counties with 1 being the healthiest. Factors such as smoking, obesity rates, drinking excessively, STD's and motor vehicle crashes make up the first map, while outcomes such as premature death, poor to fair health, poor physical days, low birth weight, and poor mental days are shown on the second map. The rankings comparing the rest of the state are as follows:

Multi-modal transportation such as walking, biking, and public transportation can also help enhance the health and overall physical activity of all residents, by improving air quality and the environment, and reducing overall traffic congestion. Numerous Neenah residents choose to walk, bike, and/or utilize public transportation as a primary means of transportation due to cost of vehicle ownership and maintenance, environmental choice, healthy lifestyle choice, etc. These types of initiatives are recognized at the state, national, and international-level to create safe, convenient, affordable, and fun opportunities for residents to walk, bike, and/or utilize public transportation as a primary means of transportation. Health and safety should be a priority concern to the citizens of Neenah. Safe Routes to School programs can assist communities and encourage children to walk and bike to school.

According to a publication from the Trust for Public Land, there are 8 ways that parks can improve your overall health:

- 1. Parks <u>increase exercise</u>. People who live closer to parks are shown to exercise more as the opportunity is there and people who regularly use parks get more exercise than people who don't.
- 2. Most moderate exercise takes place in parks, approximately 12%. Parks are where people get the kind of exercise their bodies need most.
- 3. Parks <u>reduce stress</u> and clear the mind. Outdoor areas boost focus and promote relaxation as the term being one with nature implies.
- 4. A park makeover with <u>aesthetically pleasing</u> spaces encourages use and promotes public health habits.
- 5. A <u>variety of amenities</u> can attract different users, i.e. skateparks, basketball & tennis courts, baseball, paths, and therefore encourage fun activities.
- 6. Dedicated <u>fitness zone exercise areas</u> encourage exercise and increase park use. The City of Neenah just put in workout benches at Washington Park where parents can get in reps while watching their kids play on the playground. Body fitness stations are becoming popular to encourage adults to workout.
- 7. Supervised <u>activities and programming</u> maximize a park's public health benefit. Getting people out and moving in a fun active setting is the best medicine.

8. Exercise is one of the cheapest ways to stay healthy. By promoting healthy habits, parks can help reduce health care costs.

### BENEFITS OF PARKS, OPEN SPACE, AND TRAILS

Numerous researchers have attempted and succeeded in a number of cases presenting scientific evidence that parks and open space have a number of benefits including community benefits, individual benefits, economic benefits, and environmental benefits. Community benefits can be considered those that bring a positive result to a group of people. Individual benefits are the exact opposite providing a direct result to a single person. Economic benefits, for this report, mean effects of park and open space in attracting investment, tourism, and direct positive effects to property values. Finally, environmental benefits are those that show the economic benefits of protecting and enhancing existing natural areas. These benefits are illustrated to show citizens and property developers alike the direct impact parks and open space have to the City of Neenah Residents and the Fox Valley Region.

### **Community Benefits**

- Green spaces build community. Research shows that residents of neighborhoods with greenery in common spaces are more likely to enjoy stronger social ties than those who live surrounded by barren concrete. (Trust for Public Land 2006)
- Communities with natural areas and open spaces are considered good places for children and offer high quality of life to all residents.
- Community recreation reduces alienation, loneliness, and anti-social behavior.
   Recreation facilities keep at-risk youth off the streets, give them a safe environment to interact with peers. (The At-risk Youth Recreation Project 1996)
- Recreation provides opportunities for community involvement, and shared management and ownership of resources.
- Recreation opportunities, facilities and the quality of the local environment are the foundations of community pride.
- More than 4 in 5 people agreed that parks and recreation are an essential local government service<sup>2</sup>.


### **Individual Benefits**

 Contributes to a resident's overall well-being and health by providing the opportunity for recreational activities.

- People visit their local park and recreation facilities more than twice a month, on average, with 1 in 10 visiting at least weekly, if not daily.<sup>3</sup>
- Adults living within ½ mile of a park visit parks and exercise more often than those living further away. According to the Trust for Public Lands, 79% of Neenah residents live within a 10-minute walk of a park<sup>4</sup>. This is above the national average of 55%.
- Enhances the quality of residents' lives.
  - Provides opportunities to experience and observe nature.
  - Provides opportunities for learning and living a more balanced life.
  - Provides a place for stress reduction, rest, relaxation, and revitalization through recreation.

### Attracts Investment

- Parks and open space enhance the quality of life, which attracts tax-paying businesses and residents to communities. Businesses like the Hilton and Alta Resources noted Neenah's renovation of Shattuck Park as a primary reason for their company's reinvestment in their Neenah downtown locations.
- Small company owners say recreation, parks, and open space are the highest priority in choosing a new location for their business. (Trust for Public Land, *Economic Benefits* Report)

### Attracts Tourism

- Recreation and park services are often the catalyst for tourism, a growing sector of the
  economy. For instance, the Wisconsin Department of Tourism saw a 2.75% increase of
  direct visitor spending within Winnebago County from 2018-2019 as well as total
  business sales of a 3.21% increase during the same time period.
- Visitors create direct economic values within the recreation sector as this supports the overall GDP of jobs, wages and taxes that are spent<sup>5</sup>.

### Increases Property Values

Numerous studies have indicated the positive effect of parks on property values:

 A study by Frank and Sielski on Washington County, Wisconsin parks found that for properties within 200 feet of an "active recreation park" assessed value increased \$113.00/foot. Within 2,600 feet of a "passive recreation park," assessed values increased \$4.96/foot.

### **Environmental Benefits**

### Reduces Flooding

- Natural areas reduce the rate and volume of stormwater runoff, which reduces incidents and severity of flooding. Stream flows decrease by 3.7% for every 1% increase in protected wetlands along a stream corridor.
- Trees in Neenah Parks and public right of ways intercept 2,646,510 gallons of water annually, providing a savings of \$71,726. (Analysis conducted using iTree Streets from USDA Forest Service.)

### **Enhances Air Quality**

• Street and Park trees in Neenah capture 365 tons of atmospheric CO2 per year. The trees remove 182 lbs. of particulate matter, 329 lbs. of ozone, 15 lbs. of sulfur dioxide and 56 lbs. of nitrogen oxides, for an annual savings of \$62,127.

# **Chapter 6: Recommendations**

Within this chapter you will find a list of accomplishments from the previous CORP and a list of recommendations moving forward. Rationales for the recommendations were obtained from the Park and Recreation Commission park audits and the public survey results.

The recommendations proposed in this plan are intended to serve as a guide for future development and maintenance of the parks and recreation areas within the city. Although, some recommendations may not be feasible in the near future, they represent action that should be taken if the opportunity or need arises. Recommendations that are feasible are included in the City's 2022-2026 Capital Improvement Plan, Chapter 7, Table 7-1. Recommendations should be reviewed annually by the Parks and Recreation Commission to accommodate for changing public needs, financial consideration and priorities.

### PARK LAND ACQUISITION

**RATIONALE** Goal 5, Objectives 1 and 2

**ADDITIONS TO EXISTING SITES -** If private/public property adjacent to the following parks becomes available, acquisition should be explored.

- 1. COOK: Parcel at 405 E. N. Water St.
- 2. **DOUGLAS**: Parcels at 121, 125, 129, 133, 137, 141, 145, 149, 153 Douglas St., and 709, 713, 717, 721, 725, 729, 731, and 741 S. Commercial Street.
- 3. **WASHINGTON**: Parcels adjacent along the Neenah Creek.
- 4. CARPENTER PRESERVE: Parcel north of the play area is owned by the school district.
- 5. NEW PARK LAND: New park land will be necessary as the City grows. The Park and Recreation Commission's park land acquisition strategy is reflected in the Neenah 2040 Comprehensive Plan. The areas of greatest interest for growth are in the Northwest and Southwest of Interstate 41 and the Southeast portion of the city. Approximately <u>28.97</u> <u>dedicated accessible acres</u> are needed by 2040 as listed in Chapter 4, Needs Assessment, Table 4-4.

While the City has over 390 acres available, location, accessibility, usability, and barriers inhibit safe passage creating park deserts. A "park desert" exists between Cecil Street on the north and Bell/Breezewood to the south and from S. Park Ave. west to Tullar Road with Interstate 41 and the Railroad corridor creating north/south barriers. The City should explore opportunities to secure family orientated park lands within these boundaries.

The Commission believes the best acquisition strategy is to target areas where residential growth is most likely to occur, (western boundary), and to explore park land acquisition <u>before</u> expansion occurs. This allows for the most economical purchase, as well as for appropriate planning and implementation of park development. Any new subdivision that a developer builds, must include stormwater ponds and green space, Chapter 25 of the municipal code.<sup>1</sup>

Reserving new land for park space are also listed as recommendations in the 2040 Comprehensive Plan:

Objective CF 4.3: Select and reserve future park locations <u>now</u> so new neighborhoods will develop around them.

Recommendation CF 4.3.1: Continue to expand park and recreational infrastructure as the City expands outward.

Recommendation CF 4.3.2: Provide park facilities for existing neighborhoods that are underserved, particularly in the northwest and south-central areas of the City. Identify future park land if existing parkland does not exist. (See recommendation LU 1.8.2)

Recommendation CF 4.3.3: Identify locations for future neighborhood parks in the southwest and northwest City growth areas. (See recommendation LU 1.8.1)

Recommendation CF 4.3.4: The City should take measures to ensure the preservation of natural areas. Where it is feasible, natural areas should be targeted for acquisition and inclusion as part of the park and open space system, particularly when these areas are threatened by urban development. (See recommendation LU 1.8.3)

In working in partnership with Neenah Community Development, Plan Commission, Neenah Schools, and the surrounding communities, the ability to expand park and recreation infrastructure as the City's population grows will be invaluable. A possible



new park facility located on the Future Land Use map is proposed west of the Nature Trails subdivision along Nature Trail Drive and Bluebird Ct. This would fill a park void on the westside.

### <u>LINEAR RECREATION - NEENAH TRAILS SYSTEM</u>

**RATIONALE:** Goal 2, Objectives 1 and 2

The Neenah Trails Task Force produced a report in 1997 with recommendations for on-street bike lanes and off-street trails. The City has been making efforts to implement and update the plan since its adoption. The City of Neenah currently has close to 9 miles of marked bike lanes and 18 miles of off-street trails.

The Parks and Recreation Department recognizes that a well-connected trail system contributes to community health, transportation and recreation. The City participated in the planning process for the 2014 East Central Wisconsin Regional Planning Commission's Bicycle and Pedestrian Plan, to be updated in 2022, and is an active member of the consortium that produces the Trails of the Fox Cities.

From the Community Facilities Chapter of the City's 2040 Comprehensive Plan, these trail recommendations were listed:



Commercial Street road diet

CF 4.2: Develop a green grid system of trails, paths, and routes that will allow non-motorized travel to activity centers throughout the community. Integrate this local system with a larger regional network, and educate the public on the benefits of its use.

- Recommendation CF 4.2.1: Continuously update the 1997 Neenah Trails Task Force Plan for on-street bicycle facilities and off-road trails. Implement recommendations from the updated plan. (See recommendation T 2.5.3)
- Recommendation CF 4.2.2: Increase opportunities for safe walking and biking, by linking key destinations in the City and providing access to regional trails. (See recommendation LU 1.6.1, T 2.2.2, ED 2.5.1)
- Recommendation CF 4.2.3: Consider future trails in such areas as:
  - West Bell Street
  - Breezewood Lane
  - o Harrison Street
  - o Lakeshore Avenue
  - Along the Neenah Slough
  - Cecil Street to Harrison (multi-use)

- Recommendation CF 4.2.4:
   Efforts should also continue

### **General Recommendations**

# From 2040 Comp Plan: RATIONALE: All Goals

- Regular park maintenance and upgrades.
- Continue to partner with the Neenah Joint School District for the use of facilities, including recreational facilities and explore new collaborative efforts.
- Voids exist currently in the ½ mile walking distance to neighborhood parks in some areas of the City and these should be addressed.
- Consider addressing park and

recreational needs that were identified as part of the Neenah city-wide parks and recreation survey completed in 2021.

- Utilize the existing water resources in the downtown area to increase recreational opportunities.
- Continue to expand park and recreational infrastructure as the City expands outward.
- Consider needs and enhancements for park and recreational facilities identified during the public visioning workshops.
- Neenah's parks were identified as a community asset in the public visioning process.

### What If Scenarios.... The Next Five Years

"What If Scenarios" can give the City a snapshot if a project can be accomplished in the timeframe suggested. We can take the CIP and current improvements listed to estimate the probability of completing the project in the year stated and for the cost estimated. Simply put, a what-if scenario analysis is a way of measuring how changes in one parameter could affect another. Possible examples of these type of scenarios that could influence park improvements are:

- What if there is a budget shortfall?
- What if the market costs for materials shift?
- What if the City doesn't receive a grant requested?
- What if the public reaction to the current park trends change?
- What if the City Council doesn't approve of the improvement in the timeframe?

When a five-year budget is set and costs are estimated, if these goals and timeframes are not met, the City could pay more in the future for improvements. The same thing could happen if a grant is budgeted and not obtained giving half of the funding to support the project. This doubles the cost as time moves on with inflation for materials and labor. The risk of project loss and missed opportunities can make park improvements volatile.

An example of this is shown in Table 6-1 for Baldwin Park.

The Action Plan, Chapter 7, highlights parks and projects listed in the CIP. These are a "wish list" of specific park improvements and what the Park Commission felt as priority projects. The reality of these decisions is under some degree of uncertainty. Strategic planning for best case predictions needs a driving force. If the City can get public buy-in and raise funding besides grants, bond and general budget, the chances for success increases.


No one scenario is best fit so alternatives should be developed. Anticipating a few years ahead can either make or break the project.

# **Park Project Planning**



If funding is not obtained when needed for the years budgeted, it is likely the project will cost more in the long run. Contingencies in park planning can only cover so much. A tax increase is usually never favorable but could be a scenario. On average, in 2020, Neenah spent approximately \$75 per resident, or 1.3% of the budget<sup>2</sup> on parks and recreation. As the population grows, so does the need for recreational facilities.

The action strategy is the City of Neenah's Capital Improvement Program. Other projects listed in Chapter 6 Recommendations, may be addressed through the annual operating budget.

MION

This plan works to develop and manage a working system of park and recreational facilities for the City of Neenah. It has been prepared to respond to expressed desires of residents and to address maintenance needs of existing facilities. This action program is based on priority level

by year and does not commit the Commission or the Council to all projects. Only the projects listed as "Council Approved" have been authorized with funding.

This will also assist service clubs and organizations as they consider potential park improvement projects to support. Some of the projects identified in the action program are potential candidates for receiving cost sharing funds available through the WDNR. Others could be developed through the efforts and/or monetary support of volunteers and community organizations.

In conclusion, there are many projects that are of current need in the parks and recreation department. Realizing this priority list is a guide for the future, not all projects listed can be completed within this 5-year span. Some will go beyond the year 2026. Cost analysis and estimates should be looked at annually and adjusted accordingly. A list of funding resources is located in Appendix D that the City may be eligible to apply for to offset the costs. This action plan offers a vision and course of action for Neenah to be able to provide quality parks and recreation for years to come.


# Appendix A: Survey Results




It would be nice to have more trash bins by the trails to rid of dog waste

My comment would be to continue to create inclusive spaces but the department is far and away on top of that.

I wish the parks had garbage cans. I know that people could pack out what they pack in, but they don't, and then my kids gather up everyone's trash and my car becomes a landfill.

If when my kids collected litter they could throw it away immediately, it would save my van floors from being very sticky some days.

There is not a need for more amenities; however, Neenah needs to step up their programming as Kimberly offers MUCH more and that is who you are competing against to losing families.

This survey is great, but work to get people involved, do a pop-up Education and learning event downtown with volunteer sign-ups for projects around town, and/or info about everything the park and rec does. 





#### TRUST FOR PUBLIC LANDS - PARK SERVE PLATFORM

To get a different perspective on needs assessment and walkability, the Trust for Public Lands (TPL) developed a comprehensive database to look at walkable service areas and breaks this down using US Census data. We can get a picture of where Neenah fits in comparison to the nation by a 10-minute walk for age, income, and ethnicity.

According to the TPL, here is where Neenah falls from their nationwide analysis of over 14,000 cities in America. The data represented uses a total population of 26,761 residents.










Priority Areas for new parks are mapped below as well as half mile walk service areas where an optimal place for a new park could be created. According to the TPL methodology, there are up to 5 optimized locations where new parks could make the biggest impact on the 10-minute walk. A 10-minute walk service area for all locations outside of a 10-minute walk of an existing park was created and then each optimized location was ranked by the number of residents within a 10-minute walk that currently live outside of that travel timeframe.

A questionable area is located to the east of I41 and west of the railroad tracks where Bridgewood Golf Course sits. The methodology used only recognizes city facilities and not private. Pockets of very to high are located in the center and northwest part of the city for the most parts.



The attached report gives a breakdown that the Trust for Public Land has used in its analysis and demographic representation of how many parks and where more are needed. These are aggregated results from their methodology.



### **Appendix D: Funding Resources**

The City of Neenah will continue to identify and leverage a mix of funding resources and partnership support from a wide variety of potential sources for outdoor recreation improvements and maintenance. City financial resources potentially include standard operating budgets and general fund dollars, capital improvements budgets, loans, and bonding. Donations of volunteer time, dollars, or property from local residents, businesses, foundations, and partner organizations are becoming increasingly important. Successful partnerships with private organizations, clubs, and nonprofits demonstrates the City does not have to "do it all" on its own. The most appropriate mix of such funding sources for future outdoor recreation projects should be identified and incorporated into the five-year capital improvements plan.

Grant dollars from the Wisconsin Department of Natural Resources (e.g. Knowles-Nelson Stewardship Program), Wisconsin Department of Transportation, Federal sources (e.g. Recreational Trails Act, Land & Water Conservation Fund), or foundations have long been key to major park improvements in Wisconsin communities. Additional grant dollars are available depending on the nature of the activity or attributes unique to the site (e.g. historic preservation, acquisition of floodplain conservation).

#### Stewardship Local Assistance, Acquisition and Development of Local Parks (ADLP) Subprogram

**Purpose:** The ADLP program helps communities and organizations acquire land for public nature-based outdoor recreation and improve community recreation areas.

**Allocation:** Funds are allocated on a regional basis, proportional to population. Projects compete against other projects from their region.

**Eligible Applicants:** Towns, villages, cities, counties, tribal governments, and Nonprofit Conservation Organizations (NCO). NCOs may only apply for ADLP grants to support land acquisition projects.

**Eligible Projects:** Land acquisition and development projects that provide opportunities for nature-based recreation are eligible for ADLP grants.

**Funding Priorities:** ADLP funding priorities include projects that:

- Support a local CORP;
- Support multiple uses;
- Are of regional/statewide significance;
- Result in a first-of-a-kind facility for the applicant;
- Involve two or more governmental agencies;
- Provide accessible recreation opportunities; and
- Have other priority characteristics specified in statute/code.

# Development Rights (ADR) Subprogram

**Purpose:** The purpose of the ADR program is to protect natural, agricultural, and forest lands that provide nature-based outdoor recreation by purchasing development rights and compensating landowners for limited future development on their land.

**Allocation:** Projects compete statewide.

**Eligible Applicants:** Towns, villages, cities, counties, tribal governments, and NCOs.

**Eligible Projects:** ADR grants may only be used to support projects that acquire development rights to support nature-based outdoor recreation.

**Funding Priorities:** The following types of property are given priority consideration for ADR grant funding:

- Land with water frontage;
- Land that provides a buffer between developed and natural areas; Land that connects existing natural resource protection areas;
- Land located within Department project boundaries; and
- Land with other priority characteristics specified in statute/code.

# Stewardship Local Assistance, Urban Green Space (UGS) Subprogram

**Purpose:** The UGS program supports acquisition of land for open natural areas and community gardens within or in close proximity to urban areas.

**Allocation:** Projects compete statewide.

**Eligible Applicants:** Towns, villages, cities, counties, tribal governments, NCOs, sanitary districts, and public inland lake protection and rehabilitation districts.

**Eligible Projects:** Projects that acquire land within or in proximity to urban areas that provides open space, protects unique natural features, and/or provides opportunities for community gardening are eligible to apply for UGS grants. Development projects are not eligible for UGS grants.

**Funding Priorities:** UGS funding priorities include acquisition of land that:

- Preserves land on the natural heritage inventory database;
- Implements elements of approved water quality plans or initiatives;
- Has unique natural features;
- Provides linear corridor connecting open natural areas;
- Has water frontage;
- Is of regional or statewide significance;
- Provides area for community gardens; and
- Has other priority characteristics specified in statute/code.

# Stewardship Local Assistance, Urban Rivers (UR) Subprogram

**Purpose:** The UR program helps restore and preserve the character of urban river corridors through the acquisition and development of land adjacent to rivers.

**Allocation:** Projects compete statewide. No applicant can receive more than 20% of the UR funds allocated in any fiscal year.

**Eligible Applicants:** Towns, villages, cities, counties, tribal governments, and NCOs.

**Eligible Projects:** Land acquisition and development projects that provide opportunities for nature-based outdoor recreation are eligible for UR grants.

**Funding Priorities:** UR program funding priorities include projects that: Restore river corridors following dam removal;

- Support redevelopment of brownfields;
- Acquire land with unique natural or aesthetic values;
- Acquire land that connects with previous land acquisitions;
- Provide outdoor recreation opportunities for diverse urban populations;
- Provide new or expanded access to urban waterways;
- Support local/regional plans; and
- Have other priority characteristics specified in statute/code.

# Federal Land and Water Conservation Fund (LWCF)

**Purpose:** The federal LWCF program supports development of high-quality outdoor recreation amenities in local communities.

**Allocation:** Projects compete statewide. There is a 50% local match per project due every May 1

**Eligible Applicants:** Towns, villages, cities, counties, tribal governments, and school districts. NCOs are not eligible to receive LWCF grants. A CORP is required.

Eligible Projects: Generally, all acquisition and development projects that are eligible under the ADLP, UGS, and UR Stewardship subprograms are also eligible for LWCF grants. In addition, projects that provide outdoor recreation facilities that are not exclusively nature-based, such as active sports facilities, are eligible for LWCF grants. Some exceptions apply, such as cases where the applicant intends to meet their match requirement with federal funds.

Contact a regional Grant Specialist for details.

**Funding Priorities:** LWCF funding priorities include projects that:

- Meet the needs of urban areas;
- Provide recreation opportunities for diverse populations;
- Acquire land in areas with limited outdoor recreation facilities;
- Provide multi-use and multi-season facilities;
- Enhance or preserve natural beauty;
- Are proposed by applicants which have financial resources to adequately maintain and operate the project; and
- Have other priority characteristics specified in law/code.

#### Recreational Trails Program (RTP)

**Purpose:** The federal RTP is administered in all states and is for the development and maintenance of recreational trails and trail-related facilities for both motorized and non-motorized recreational trail uses.

**Allocation:** Eligible sponsors may be reimbursed for up to 50% of eligible project costs.

Eligible Applicants: Towns, villages, cities, counties, tribal governing bodies, school districts, state agencies, federal agencies or incorporated organizations are eligible to apply for funds. Incorporated organizations are those that are incorporated under s. 181.32, Wis. Stats., whose primary purpose is promoting, encouraging or engaging in outdoor recreation trails activities.

**Eligible Projects:** Eligible projects in order of priority are:

- Maintenance and restoration of existing trails
- Development and rehabilitation of trailside and trailhead facilities and trail linkages
- Construction of new trails (with certain restrictions on federal lands\*);
- Acquisition of easements and fee simple title to property for recreational trails or recreational trail corridors (must comply with the provisions of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended)

\*Construction of new trails crossing federal lands only where permissible under other law, necessary and required by a statewide comprehensive outdoor recreation plan, approved by the DNR and the administering federal agency and consistent with applicable federal land management plans and policies.

**Funding Priorities:** Non-motorized 30%, Motorized 30%. Diversified 40%

# Wisconsin Urban Forest Assessment (WisUFA)

Current Contact: Chase O'Brien, Urban Forestry Grants Manager 608-640-6143

**Purpose:** Assistance for tree maintenance, planting, and public awareness.

**Allocation:** \$1,000 to \$25,000 of grants awarded with a 50% local match per project due on October 1.

Eligible Applicants: Towns, villages, cities, counties, tribal governments, and NCOs. Eligible Projects:

- New, innovative projects that will develop sustainable urban and community forestry programs, not to subsidize routine forestry activities.
- Competitive start-up cost-share grants of up to \$5,000. Available to communities that want to start or restart an urban forestry program.
- Catastrophic storm grants fund tree repair, removal or replacement within urban areas following a catastrophic storm event for which the governor has declared a state of emergency under s. 323.10, Wis. Stats.

**Funding Priorities:** Funding is prioritized for communities needing to develop an urban forestry plan. This includes worker training and street tree inventories.

# Surface Transportation Program – Urban (STP-Urban)

**Purpose:** Provides flexible funds that can be spent on a wide variety of projects, including roadway, bridges, transit facilities, and bike and pedestrian facilities.

**Allocation:** A 20% match is required. Nonconstruction projects must be over \$25,000, and construction projects must be over \$100,000. Cycles are usually February of each year.

Eligible Applicants: For urban areas, annual

funding for each of the two categories (5,000 to 20,000 and 20,000 to 50,000 in population) continues to be allocated by population

#### **Eligible Projects:**

- Complete Streets<sup>1</sup> Roadways designed and operated to enable safe, convenient, and comfortable access and travel for all users. Pedestrians, bicyclists, motorists and public transport users of all ages and abilities are able to safely and comfortably move along and across a complete street.
- Accessible Sidewalks and Street Crossings
- Planning and design of pedestrian accommodations.

# Safe Routes to School Grant Program (SRTS) and Transportation Alternatives Program (TAP)

**Purpose:** Federal and State assistance to combat childhood obesity and reestablish walking and bicycling to school safely.

**Allocation:** 20% local match per project by an eligible local sponsor

**Eligible Applicants:** Local and regional governments, schools and districts, non-profits, tribal governments, public land agencies, transit agencies, and regional transportation authorities.

#### **Eligible Projects:**

 The project must fit within one of the federal eligibility categories and must comply with any additional WisDOT TAP policies as outlined in these guidelines.

- The project must relate to surface transportation.
- The project must have an eligible sponsor.
- The project must be selected through a competitive process.

With the acquisition of house on Water Street, one can see the potential of a park redevelopment. One house needs to be acquired (405 Water Street). It would open it up for added amenities coming off the Arrowhead track for the south. P.S. Bill Dunwiddie championed the slope on River Street as a modest sledding hill.

If we aren't factoring in money or staffing, my vision for this park would be to create a truly fantastic inclusive playground and park that could become a destination park for the area (and as a side note, would also give us a 'reason' to maintain bathroom facilities in this neighborhood park that otherwise wouldn't have them.) I'm not giving up the dream, but this is also a nicely located park in relation to the Loop and would be a nice place to for looping families to begin their walk or use it as a place to pause, snack, play. I've recently been to several parks near water and all of them had bench swings (not swing sets) in addition to some stationary benches. I think this would be a nice enhancement as the wooden benches reach the end of life. Additionally, I would like to see some actual swings in the park. They can be decorative vs. metal swing sets, but something for the younger audience — and their grownups who will appreciate the distraction while they enjoy the park themselves. This would be a nice area to have some step-down areas for touch the water (or hang your feet in the water) features. Maybe a couple of places on each side of the lighthouse.
